Please Note:

- 1) Admission process will conclude at 05:00 PM daily, but if required may continue thereafter on the same day or next day or even on Holiday, if any, at the sole discretion of admission committee. Lunch Brake Time will be 2:00 PM to 2:45 PM.
- 2) Admission committee reserves the right to amend the above mentioned or any subsequently declared schedule, reporting time or procedure in view of remaining vacancies, given timelines, directions of CET cell etc., so candidates are required to peruse the college notice board and college website: <https://ydlawcollegeparatwada.org/>.
- 3) This admission process is online, time bound and any wrong admission even if done by mistake, is subject to heavy penalty to admission committee from Admission Regulating Authority. Hence any direct or indirect undue interference, pressure, unnecessary arguments, misbehaving etc., in the working of Admission Committee will lead to strict legal action and immediately disqualify the candidate for IL Round. If due to any undue interference of anybody and the time is exhausted and seat/s remains vacant, such erring person will be held liable and the admission committee will not be responsible in any way for any loss of merit listed candidates.
- 4) This being a full time course, minimum 75% attendance is mandatory along with all other criteria prescribed by Sant Gadge Baba Amravati University, Bar Council of India, Government of Maharashtra and other relevant authorities.
- 5) Candidates with any sort of discrepancy including not uploading original document, all mark sheets with conversion certificate, multiple attempt certificate, uploading invalid, outdated, invisible document, name mismatch, marks mismatch in CAP form and mark sheets, number & date mismatch in caste and CVC, etc., will be rejected out rightly and next candidate will be considered as per inter-se merit. So the candidates are advised to check their CAP / ACAP form their own login first by clicking on 'print application form' button and bring to notice any discrepancy, if any, during their turn in the admission process.
- 6) Admission is subject to conditions mentioned in CAP brochure, relevant directions and notifications of CET cell etc., which includes online payment of seat acceptance fee Rs.1000/- to CET cell, inter-se merit, original document verification, no-discrepancy in documents etc. & payment of prescribed college fees.

7) After reporting for admission as per schedule, candidate will have to submit self-attested photocopy of score card at the reception, counter, make entries and sign in reporting register (within reporting time i.e. 09:00AM to 01:00PM), receive token number slip from reception counter and write Application ID beginning with **L325.....**, name and date on it, receive admission form and read it thoroughly, completely fill up the admission form in own hand writing, sign every page, as per the sample admission form available on notice board. All photocopies of documents must be self-attested and numbered and wait patiently for his /her turn in the waiting hall only. Single candidate will be allowed entry inside admission hall at a time as per token number. Only eligible candidates in IL Merit List will be called as per given token numbers in the admission hall, documents will be verified and subsequently admitted if found eligible. Hence nobody should rush in the admission hall except upon being called by individual name.

8) Cell phones, talking loudly etc., are strictly prohibited in the college premises and in the admission hall particularly.

9) College admission committee will not be responsible in any way for non-admission due to ineligibility of candidate, technical issues, medical emergency, expiry of time limit, unforeseen circumstances or any situation beyond control even after due care has been exercised.


10) Admission process is completely transparent. But still if any candidate feels aggrieved, after reading CAP brochure, relevant directions and notifications of CET cell, Institution Level (Round IV) Schedule cum Provisional Merit List etc., candidate may give written submission personally to IL Admission Grievance Redressal Committee consisting of Adv. Prof. Shabana Mohd. Madam, Adv. Prof. Mangesh Harne Sir, Ms. Anju Chavhan Madam during working hours in the college.

11) This schedule / merit list is subject to correction of any inadvertent mistake but the same has to be brought to notice within stipulated time line (i.e. before actual beginning of admissions) for the concerned list.
